#### **GENERAL RESPONSIBILITIES:**

Responsible for coordinating mental health training and services to establishing comprehensive school-based mental health services under the Benton Franklin Safe Schools/Healthy Students Initiative in six school districts.

#### Qualifications:

- 1. Master's Degree in Mental Health Services and prior experience working in a mental health service agency. Experience working with schools and multiple community agencies.
- 2. High commitment to task accomplishment and flexibility in work hours.
- 3. Effective oral and written communication skills.
- 4. Demonstrated ability to work well with people.

#### **ESSENTIAL FUNCTIONS** (to include but not limited to):

- 1. Coordinate training for mental health specialist utilizing "Best Practice" models to ensure continued staff development is aligned with Safe Schools/Healthy Students Grant.
- 2. Develop an inter-district, building wide intake and referral process to services that expands the safety net and assures that no student falls through the cracks.
- 3. Coordinate inter-district training for all school personnel, focusing on building-wide intake and referral process to mental health specialists.
- 4. Develop and implement communication system between contracted mental health facilities and schools to ensure that student and family needs are being met.
- 5. Assist schools in adopting the most successful prevention and intervention strategies that address needs in each building.
- 6. Assist Safe Schools/Healthy Students Administrator coordinate with district Prevention/Intervention Specialist student assistance team development and implementation.
- 7. Assist in training three schools the first year on the "Blue Line Counseling Model".
- 8. Provide staff development on mental health and co-occurring disorders among student populations.
- 9. Provide training to students, parents, and relevant partners as requested and needed.
- 10. Coordinate prevention activities with Prevention/Intervention Specialists for student engagement and empowerment.
- 11. Provides technical support to schools and communities on mental health services, programming and concerns.

- 12. Works cooperatively with schools and communities on prevention media campaigns.
- 13. Coordinates collaboratively activities for mental health awareness month with mental health community partners and school districts.
- 14. Mobilize communities through collaboration and communication to help schools identify gaps in mental health services.
- 15. Work comprehensively with organizations to develop and/or enhance ongoing mental health services in all six school districts and communities.
- 15. Responsible for data gathering and data reporting to ensure for accurate outcome based program evaluation.
- 16. Report all outcomes and concerns to ESD 123 Safe Schools/Healthy Students Administrator
- 17. Comply with ESD 123 policies/procedures and all state and federal laws governing Professional conduct and confidentially.
- 18. Other duties as assigned.
